Agenda Item 3: To receive and approve the Minutes of Meeting 12th October 2021.

On a **proposal** by Councillor Newman and **seconded** by Councillor Ings It was **Resolved** that the minutes of Meeting 12th October 2021 be accepted as a true record of proceedings. The papers were signed accordingly.

Agenda Item 4: Update on matters carried forward from previous meeting:

a) Footpath Village Green

Councillor Aldridge sent in a short progress update regarding consent for the new bridge. To summarise: -The Church Commissioners are yet to provide a draft legal agreement and he will follow up on that. There will be a meeting with Councillors, and the bridge builder on Thursday afternoon in order to discuss the design and engineering.

Agenda Item 5: -Report from County Councillor Jeremy Hunt

County Councillor Jeremy Hunt reported

- Centurion Way. The tree felling is complete, but unfortunately the installation of the ramp has been delayed due to the need to divert the highways team to emergency works on the A285. The road has collapsed and is currently undergoing major repairs.the new ramp is installed.
- Flooding West Sussex Operation Watershed Team and others are arranging to investigate the culverts in Chalkpit Lane and Lower Lavant. Using the Operation watershed grant application process the aim is to clean the gullies out. A culvert at the bottom of chalkpit Lane has already been cleared out by WSCC Highways, which has already improved the situation.
- Tree Planting Request to identify areas for Tree replacement around the Village.

Agenda Item 6: District Councillors Report

Report received with thanks Questions: -

Councillor Newman would like clarification if District can demonstrate there was a 5yr land supply which would prevent developers building further.

Councillor Pickford would like the Local Plan team to revitalise the Jacobs Road Survey Report .pg 22 looking at rat running through East - West Lavant based on a housing growth of 440 a year. The projection is currently 659 per year a 50% uplift. It needs further work to see if the plan would work without A27 mitigation. A statement regarding the northern route is the traffic is to be separate North – South / East – West- the local traffic to the through traffic. County Councillor Jeremy Hunt clarified that, although he hadn't supported the decision, the stated preference put forward to Highways England by the County Council, following the BaBa27 meetings, was for a mitigated northern

route, but as an alternative a mitigated southern route should be fully investigated. Highways England chose neither due to cost and other factors. A full explanation of why if any solution is going to be left out is required.

Agenda Item 7: Chairman's Report

Speedwatch Team

A report to Lavant Parish Council October 2021

The Lavant Speedwatch group started in March 2019. For a number of months we were not operational due to the pandemic.

Since its inception the group has identified over 800 vehicles travelling at speeds in excess of 35mph on village roads with 30mph speed limits. 13 of these have been recorded twice during the period. The group has four members currently. To provide adequate cover for holidays and illness, we need more volunteers. With more volunteers we could do more.

As you know, PC Jason Lemm loaned David Priscott and the other Lavant CSW volunteers some speed calming equipment that they have been using for the last six months. We need to find funding for David and the others and get them their own kit for Lavant that they will own and keep as a CSW group.

The cost of a new Bushnell speed device starter kit is £446.50 plus vat which comes to a total of £535.80. PC Lemm can apply for upto £500 from the Police property act fund to pay for this. As this does not quite cover the required amount, a request for Lavant parish council be willing to pay the shortfall. All councillors agreed and a budget payment of £150 was to given.

The clerk will advise PC Jason Lemm who will continue his efforts to complete the funding application. The grant will come direct to the Parish Council. Speedwatch can then order the new kit and Parish Council will be invoiced.

Raughmere

Working towards the appeal ,briefing documents are being sent out to all councillors and a note of Thanks to Councillor Tim Aldridge for responding with his Nitrates and Agriculture reports although nothing significant that would be used for the appeal.

Speedwatch surveys show that the data is difficult to challenge. The evidence does not consider Hunters Race or East-West traffic. Comment will be made further.

A landscape consultant – Terra firma is being used by CDC .A request will be put forward for Lavant to have direct access to them.

Chairman explained to the council to retain the option to have legal professional representation in the Public Inquiry is a Rule 6. Lavant would become a party who can be heard to set out the case why planning permission should be refused. A rule 6 letter to be drawn up by a solicitor or junior barrister of Landmark Chambers immediately costs approx. £600.00 +VAT.

The proposal was to put the Rule 6 letter forward to the Planning inspectorate on behalf of Lavant Parish Council. The council **Resolved** to spend £600 +VAT from the legal budget. Questions From: -

DC David Palmer was concerned about engaging too many barristers. Would it better to use the quality CDC barrister? Request advice from CDC.

Councillor Reynolds – To the Clerk -Is the Parish Council allowed to spend on legal costs? What budget does it come from? What is the Parish Council held responsible for?

Councillor Newman – Can we present Lavant Parish Council using a Parish Councillor?

Going forward the council representatives will meet with CDC and further discussions and fact finding can then be considered to whom will fund the junior barrister - 19 houses adjacent to the site, Summersdale Residents Association may wish to assist with the cost of a junior barrister £40-45k and defend their position (a fighting fund) and Chairman asked how much the council would look to contribute a sum for example of £10,000.00 from Parish Council reserves. No decision on this was made at this point.

Agenda Item 8: La Volunteers Report

Councillor Newman would like the council to defer this report until next meeting when he will have more interesting information on equipment to purchase in the next budget.

County Councillor a thought to request the Volunteers that every six months to clear the culvert at the bottom of Chalkpit Lane.

Agenda Item 9 Playground Update.

Councillor Quest gave an update of the progression of the project. The Playground companies have been sending in quotes and a preferred company has been chosen to look at repair and upgrade which is much less costly than the previous quote.

It was agreed by council a representative of Lavvoles would take the equipment to be annually services with local contractors.

VI. Request to purchase x2 Green Glasdon bins for Playground.

It was agreed that Clerk will order x2 Green Glasdon bins £270 each bin in colour green and concrete fixing bolts with VAT inc to be delivered to ClIr Newman.

They offered a timber stile arrangement as a possible solution.

The Parish Council discussed this offer and came to the conclusion that we believe it would be preferable to plant thick hedging and trees on this part of the site to avoid direct access onto the busy roundabout.

<u>Report from District Councillor to Lavant Parish Council,</u> <u>Tuesday November 9, 2021</u>

1. Introduction:

Two issues affecting the Parish have come up in the last month:

- Some small progress on the Local Plan
- National Highways is taking a serious look at the A27

2. Local Plan:

The two issues standing in the way of a valid Local Plan are the state of the A27, and water and sewage issues.

A meeting of all Councillors ten days ago revealed that dialogue between CDC and National Highways (the new name for Highways England) have been pretty constant.

CDC's divisional manager for Planning Policy, said he was pleased with the "level of engagement of National Highways". He also revealed that further investigative work by CDC had produced a figure of 5.1 years of land supply for our housing requirement. This is a significant improvement on the March 2020 figure of 4.3 years supply.

For a Local Plan to be valid, it has to show a minimum of five years land supply.

Hopes are now that a valid Local Plan can be delivered by July next year, a four-month delay from the original date of March 2022.

My instinct tells me that at last progress is being made; but don't hold your breath on the deadline of July 2022.

3. <u>The A27:</u>

For the time being, CDC is "not promoting the Stockbridge Link Road." But it could come back into the reckoning at a future date. CDC is trying to move things forward with an "adopted mitigation package" for the A27. This includes works to the Fishbourne, Bognor and Portfield roundabouts costing £26m.

National Highways has booked a meeting with all County and District Councillor at 0930 on Friday Nov. 12. They are also approaching Parish Councils for similar consultation,

It feels to me as if the future of the A27, and whether we go for a Northern bypass or enhancements to the existing southern bypass, are about to take centre stage again.

I shall report regularly to you on progress.

As you probably know, I am personally fiercely opposed to a new Northern Bypass
