a) Footpath Village Green

Councillor Aldridge had circulated the design previously and presented the proposal to the councillors.it will be engineered properly and his estimate will be sent to council because of his locality and respectability he would be put forward as the contractor chosen by council. The council approved the design.

Unanimously agreed to engage the Carpenter to proceed with the bridge construction and confirmed the build is due approx. June/ July when the river dries up.

# b) Sewage

Councillor James Pickford confirms an Agenda has been sent onto Southern Water to request a meeting. An outline covering an overview moving onto the sewer system and wastewater treatment plant. There are interesting studies from Portsmouth University regarding sampling discharge water the worst water treatment works run by Southern Water effecting the water quality. A drone spotted a mass and research results form one of the questions to raise with Southern Water.

The field manager from Southern Water is looking into the increase in data from the water plant. It is emphasised to residents to call in any nature of odour from the sewers to ensure all records are reported.

The Southern Water Planning Area Manager has been invited to the meeting with Southern Water.

### Agenda Item 7: Chairman's Report

### • Memorial Hall

The project to upgrade the men's changing rooms / showers has been led by the Memorial Hall Chairman and committee mentioned in minutes 15<sup>th</sup> September 20021 & 7<sup>th</sup> January 2022 agenda min ref 7 to go with the new sports field.

Confirming the quotes from contractors received in the region of £42,500. plus, VAT A proposal donation from the memorial hall of £12,500 and Lavant Parish council will use CIL monies proposed to council £30,000 claim the VAT back. All agreed through SALC finance and regulations all followed in accordance with our Financial Regulations The entry had been made onto Contract Finders website and confirmation that the procedures to award the contractor are followed will be awarded to proceed with the upgrade.

### • Sewage

There will be an exert on the BBC breakfast as they cover the worst wastewater issue in years with a great mass of pollution in the river. Portsmouth University professors have identified the discharge currently is x7 times over the water quality with the effects on the water animals being monitored. Contacts suggested towards our Environment team members.

### • Platinum Jubilee Tea Party

Due to an interruption of ill health the last meeting was cancelled. However, plans are coming through well. Mugs, Flagpole, flags, cakes, games underway. • Raughmere – Successful result in the Planning Application Appeal.

### Appeal Ref: APP/L3815/W/21/3284653

### Field South Of Raughmere Drive, Lavant West Sussex, PO18 0AB

The appeal is made under section 78 of the Town and Country Planning Act 1990 against a refusal to grant outline planning permission.

The appeal was made by Berkeley Strategic Land Ltd against the decision of Chichester District Council. The application Ref LV/20/02675/OUTEIA, dated 16 October 2020, was refused by notice dated 16 July 2021.

The development proposed is an outline application with all matters reserved (except for access) for the development of 140 dwellings, public open space, landscaping, parking and associated works. **Decision** 1. The appeal is dismissed.

Reading the reports fully under preliminary matters concludes local plan carried minimum weight. The inspector concluded a 5.039 years housing land supply - it concludes to say there is no material consideration. In accordance with the development plan all the hard work that was put into this plan is significant and thanks given to the greater public who contributed to its entirety.

The neighbourhood plan review is due shortly and consult with SDNP. Much less onerous this time as the framework is there. Looking at the revisions of the development plan there is the possibility to put pressure the District council to ensure the Strategic Gap is more formalised as a protected gap. A discussion can be to Look at Eastmead planning appeal the lessons learnt is to reflect the affordable houses allocated within this development.

### • New Sports Field

Communication continues with the Development Owners Sunley / Crayfern. Before the transfer of land at the end of the development project, various snagging points will need to be addressed to ensure a smooth handover. These will be discussed at a meeting with them on Thursday 10<sup>th</sup> March.

### Agenda Item 8: Environmental Report

The benefactor of donation of Trees have been planted up centurion way. The Lavant volunteers will water the trees to ensure they are looked after.

The Tree guard for the Elizabeth Oak Tree. The donator of the sapling wished to contribute towards the plaque a suggested figure of £50 donation is thought to be very generous and will be communicated by Cllr Jenny Goldsmith.

A donation of a Yew Tree to council has been accepted and will be planted along the Lavant Down. Primary school are going to plant to commemorate the Platinum Jubilee and the school are going to supply the commemorative plaque. It will be well watered and looked after with a strimmer proof guard.

### Bird Walk

Lead by a South Downs Ranger was deemed to be a successful walk. A number of people saw and heard 23 different species along the Sheepwash Lane chosen route.

### Bat Watch

A member of the environment team has been qualified as a Bat Identifier; Bats are starting to become active again as the weather warms up. A certificate will allow him to run some Bat Surveys around Eastmead going forward to inform the council of the activity around the area.

The monies all came within the allocated funds from the CIL budget given. All agreed to go ahead.
